Civil Defence

- Volunteer-based emergency management corps, mandated to protect the citizens from Military attacks, Natural and Man-made disasters.
- An integral component of Nation's Defence Strategy and the preparedness level is linked directly to the crisis absorbing and recovering capability of the Nation.
- It mainly comprises of local citizens, anchored within the community and invariably acts as 'first responders' in any crisis situation.
- Apt example of Community based Emergency Response / Crisis Management model.





CD Act, 1968

 "Civil Defence includes any measure, not amounting to actual combat, for affording protection to any person, property, place or thing in India or any part of the territory thereof against any hostile attack of the whole or part of its effect, whether such measures are taken before, during, at or after the time of such attack, or any measures taken for the purpose of disaster management, before, during, at or after any disaster"

Civil Defence, all over the world has been a government programme, that provides for response against impacts of serious emergencies, disasters and wars. It is an organised non-military effort to prepare citizens for combating natural and man-made disasters.

Geneva Conventions and their additional protocols are International treaties that contain the most important rules limiting the barbarity of War. They protect people who do not take part in the fighting (Civilians, Medics, Aid Workers) and those who can no longer fight.




